Topic: The Renters' Rights Bill

The Renters' Rights Bill is the most significant reform within the private rented sector since the Housing Act 1988. The tenancy reform it seeks to introduce will have far-reaching consequences for both tenants and landlords. Alice's talk considers the tenancy reform provisions predominantly contained in Part 1 of the Renters' Rights Bill exploring:

- The end of Assured Shorthold Tenancies
- Rent increases
- Renting with pets
- Rental discrimination
- Rental bidding

SIMON GOLDBERG K.C.

Topic: A Review of Adverse Possession

Simon Goldberg K.C. will discuss the landmark Supreme Court judgment in Brown v Ridley and another [2025] UKSC 7, in which he successfully represented Mr and Mrs Ridley. The case clarified the period during which an applicant relying on the boundary condition in paragraph 5(4) of Schedule 6 to the Land Registration Act 2002 must hold a reasonable belief that they own the land they seek to register.

Appointed King's Counsel in 2022, Simon is head of Trinity Chambers' Business and Property Team. Recognised as "a standard setter and standard bearer for the North East", he is one of the region's leading Commercial and Property litigators, with regular appearances in the Commercial Court, Circuit Commercial Court, the Business List, and both the First Tier and Upper Tribunals.
